

OTHER MILESTONES

- 1882 - Building the Church —
It was necessary for the Mission to execute a mortgage to Cornelius W. L. Martine for the purpose of refunding amounts advanced for the payment of mechanic's wages and materials used in the construction of All Saints' Church.
- 1882 - November —
Mr. Cornelius Mesler, Sr. was appointed Church Sexton, the wages to be \$1.00 per Sunday "for cleaning and making fires".
- 1890 - A new organ was bought from Mason and Hamlin Organ and Piano Company for \$180 less \$5.00 allowed on the old organ.
- 1892 - The Girl's Guild raised \$30 for purchase of a Chancel Light, and asked permission of the Board of Trustees for their putting it up.
- 1892 - December 1st —
The Board consulted with two legal advisors to determine whether it would be legal to serve on both the Board of Trustees and the Vestry. Both advisors said it would be legal to do so.
- 1892 - December 29th —
Letter from the Diocese saying that the allowance from Convocation would be stopped as of February 1st, 1893, unless a resident rector was called by then.
Vestry replied, "It is expected that our affairs will be in such shape that a call will be extended to a minister."
- 1893 - January 8th —
There was a meeting of the congregation immediately after the Sunday Service to submit two propositions:
1. To sell to the Vestry and Wardens the land and building of the Mission for the amount of the mortgage - \$3500.
2. To lease the church property to the parish, wardens and vestrymen, for the amount of the interest on the bonded debt, and \$50. more for the annual retirement of Bonds, — the Mission to have the privilege of holding meetings and services in the church at stated periods, — the parish to pay all running expenses.
A vote was taken after considerable discussion, 10 were in favor of the 1st proposition, — 7 were in favor of the 2nd.
- 1898 - October 30th —
The Rev. Edward True, Rector, resigned. A Call was extended to the Rev. R. E. Pendleton, lately of St. Luke's, Brooklyn. A committee called on him in April, 1899 to ask "whether he would insist on wearing the sacrificial vestments". His answer, — "he would not wear the sacrificial vestments or practice anything of ritual that would be contrary to the expressed wishes of the Vestry.
- 1911 - June —
A fire on the church property. The outhouse burns down. Carpenter A. Frenz asks \$248 to build a new one.
- 1919 - June —
Vestry planted row of trees (maple or other") on the church property line.
- 1919 - October —
Gas installed in church cellar. Gas radiators to be used in church to supplement hot air heat.
- 1923 - Albert Riblet recognized by Vestry for past valuable service on the Board.
- 1928 - Girl's Friendly Society is organized with Mrs. Frank Cavanaugh, adult advisor. Charter members: Alice and Ruth Fleming, Mary and Emily Pandick, Irene and Mildred Persson, Jean Tompkins and Genevieve Wall.
- 1948 - The Glee Club of St. Peter's School, Peekskill, presented a Concert in All Saints' Church — half of proceeds went to the school, and half went into the Parish House Fund.
