Already the fastest, most powerful planes of their type in the world, the U.S. Navy's Curtiss SB2C Hell-Diver dive-bombers are now rolling off the mile-long assembly line, equipped with an even mightier engine and four-bladed propeller. Curtiss Wright has revealed that the latest models of the hard-hitting "Hell-Diver" are powered by an air-cooled Wright Curlone engine while to turn Wright Cyclone engine, able to turn up substantially more horsepower than the 1,700 H.P. Cyclones with which the earlier types were equipped. Horsepower rating of the new engine is restricted information.

## SERVICE MEN'S ADDRESSES STILL SOUGHT

Acting County Clerk Grover C. Tranor, appealing anew for latest addresses of Union County's men and women in the armed forces, announced he will keep sending out absentee ballots so long as it appears humanly possible for them to reach the service people in time for return by Election Day, November 7th.

A state - wide impression has arisen that Aug.15 was the absolute deadline for transmission of the ballots, but Tranor explained the new absentee voting law actually directs county clerks to send them as soon as possible after that date. Some 22,700 have been mailed from Elizabeth.

Already boasting speed enough to keep up with the latest U.S. Navy fighter types, the Helldiver - with its new power plant - now also has a better rate of climb -a factor which will prove invaluable in combat, where quick getaway after bombs are dropped is of vital importance.

A heavyweight, the Helldiver weighs almost seven tons. Its wing span measures almost 50 feet. Armament and performance data are restricted. The wings of the Helldiver fold to facilitate handling and storage aboard the Navy's aircraft carriers. The crew of the Helldiver consists of 2 men.
