three Oak Leaf Clusters and a Presidential Citation awarded his group, Sergeant Vernon has completed 47 missions.

A great number of the missions on Sergeant Vernon's combat record consisted of attacks on railroad yards and communication centers during the 15th Air Force's determined effort to disorganize the Nazi army's transportation and communication systems.

George also participated in numerous sorties against tactical targets on the Western Front in coordination with the Allied ground forces offensive. He wears the European offensive. He wears the European theatre of operations campaign ribbon with four battle stars, signifying his participation in the battles of Germany, Rome-Arno, Austria-Hungaryand Yugoslavia.

Entering the service in July, 1943, while a pupil in SPHS, he received his basic training at Miami Beach, Fla., and won his gumner's wings at the AAF Gunnery School at Harlingen, Tex. Following training at Walla Walla, Wash., he went overseas in September, 1944.

Cpl. Michael Rossi, son of Mr.and Mrs. Canzio Rossi of Westfield Road, has been awarded the Silver Star for gallantry in action during the 25th Infantry (Tropic Lightning) Division's battle for San Manuel on Luzon in the Philippines.

Michael, a member of a combat patwol in contact with a small group of Japs, went to the rescue of a woundedFilipino guerilla and succeeded in removing him to a place of

safety.

The citation which accompanied the award stated: "This courageous action by Corporal Rossi in leaving his place of safety and exposing him self to enemy fire was an inspiration to the men with whom he was fighting.

A gunner corporal in a field artillery unit, Michael also fought Japs on Guadalcanal and New Georgia in the Solomon Islands. Enlisting in the Army in June, 1940, he trained at Fort Solcum, N. Y. He went to Hawaii in September, 1940. He has been awarded the American Defense-ribbon andbattle stars for Guadalcanal and New Georgia. \*\*\*\*
